Okulickiego 21, 05-825 Grodzisk Mazowiecki, entered into the register of entrepreneurs maintained by the District Court for the capital city of Warsaw in Warsaw, 14th Commercial Division of the National Court Register under number KRS 0001064222, having NIP 1182016124, REGON 142112826 (hereinafter referred to as the "Club Owner"), declares to be the owner of the gym operating under the name "GRAFIT" (hereinafter referred to as the "Club"), located on the first floor of the Elemental office building in Grodzisk Mazowiecki at ul. R. Traugutta 42a, 05-825 Grodzisk Mazowiecki.

I, THE UNDERSIGNED, HEREBY DECLARE THAT:

- 1) I have read:
 - Grafit Club Regulations,
 - Regulations for the Provision of Services by Electronic Means,
 - Privacy Policy,
 - Cookie Policy,

and I accept provisions thereof and undertake to comply with them.

- 2) I am aware of the rules of using the Club, such as:
 - Access to the Club is only possible using the Club Card or Partner Cards accepted by the Club. The Client is obliged to use the card independently each time to release the turnstile or entrance gate lock.
 - Any form of bypassing the access control system (e.g. entering without using a valid card, entering behind another person, jumping over a gate) is treated as unauthorized entry and an attempt to circumvent the rules, which results in sanctions provided for in the Grafit Club Regulations.
 - The scope and time of access to the Club depends on the type of service bought (pass, single entry, partner card). In particular:
 - The OPEN GYM pass valid for 30 days allows using the gym 7 days a week, 24 hours a day.
 - The SMART pass valid for 30 days allows using the gym 7 days a week from 6:00 a.m. to 4:00 p.m.
 - The MINI pass allows 4 entries within a 30-day period each available 24/7.
 - Single Entry a trial entry to the Club after registration at the Reception (Monday–Friday 8:00 a.m.–8:30 p.m.).
 - Partner Cards (e.g. Multisport, Medicover Sport, PZU Sport, Fit Profit) Monday–Friday 8:00 a.m. 8:30 p.m.
 - The Client's rights to use the Club services, resulting from the card held, are personal and cannot be transferred onto other people. Club services can only be used by the person to whom the card was assigned in the Club system. The Club has the right to verify Client's identity on the basis of a document with a photo.
 - Should it be discovered that the card is being used by an unauthorized person, the card will be retained, the person will not be
 allowed to enter the Club, and the cardholder will be charged with a contractual penalty in the amount equivalent to the
 purchased, unused services assigned to the card.
 - Parking area and lockers are intended exclusively for people currently staying in the Club. Lockers are opened and closed using a club card and must be emptied after each visit. Items left in lockers for more than 30 days are disposed of.
 - A Client who has been using the Club's services continuously for at least 90 days has the right to suspend the service a maximum of 3 times within subsequent 180 days. Each suspension may cover a period of up to 7 calendar days.
 - All devices are marked with a QR code containing instructions for safe use it is essential to read and follow them before first
 - Clients with health problems or pregnant women should consult a physician before use.
 - Consumption of alcohol, drugs and smoking is prohibited within the Club.
 - It is not allowed to bring in accompanying persons, children under 15 years of age or animals into the Club. Bringing in an unauthorized person is equivalent to making the card available to another person.
 - Persons aged 15 and over may become club members only with the written consent of their legal representative.
 - The facility is monitored and recordings are stored for a period of 30 calendar days.
- 3) Lundertake to inform the Club staff about any failures, irregularities and security breaches by reporting them at the Reception or by calling the emergency number +48 506 174 845.
